NHPHA Leadership Management

Championing Public Health Policy & Practice

NHPHA develops and advocates on priority public health policy areas. NHPHA utilizes education and advocacy to help enact effective policies that support both population-based and individual health throughout NH state and communities. The association tracks public health legislative bills and looks at policy matters in terms of their potential impact on the public's health in New Hampshire.

In 2022, the legislative session had more than 40 bills introduced that would have undermined our public health sector. Some of these bills negatively impact the NH childhood vaccine program and diminish our data collection systems. However, the NHPHA and its partners advocated on behalf of public health professionals in NH to defeat these bills. Here is a recap of four public health bills:

House Bill 1210, relative to the exemption from vaccine mandates. The bill requires granting of conscientious exemption from all vaccines for all employees of all private employers and students at colleges and universities who request it. The bill was referred to an Interim Study.

House Bill 1639, relative to the youth risk behavior survey in schools. The Senate amended the bill to allow electronic notification to parents before the Youth Risk Behavior Survey is administered. The bill then died in the Conference Committee.

House Bill 1455, relative to state enforcement of federal vaccination mandates. The bill prohibits any state government agent from enforcing COVID-19 federal vaccine guidelines or mandates. Governor Sununu signed the bill in June 2022.

House Bill 1606, which would make the state vaccine registry opt-in participation vs. opt-out. The House amended the bill to exclude information about those who decline vaccination in the registry. The amended bill also allows a patient to receive a copy of his or her vaccination records from the registry. Governor Sununu signed the bill in June 2022.

House Bill 1022, which would allow for the prescription of ivermectin to treat COVID19, was vetoed by Governor Sununu in June 2022.

Promoting Health Equity Through Partnerships

NHPHA believes building partnerships is essential for community-based solutions for advancing health equity by making it a shared vision and value, increasing the community's capacity to shape outcomes, and fostering cross-sector collaboration. NHPHA continues to build new and strengthen existing partnerships in NH through the following activities:

COVID-19 Equity Task Force

NHPHA continues to support the COVID-19 Equity Task Force. The task force has over 150 members representing community-based organizations, state and local health agencies, academia, schools, healthcare membership associations, and many local organizations impacted by the pandemic. The Task Force has met semi-monthly, with 40-60 individuals participating and new participants joining regularly.

The task force members discuss concerns related to immigrants, the digital divide and education, food insecurity, mental health and substance use, older adults and people with disabilities, and climate and environment equity. Participants are led with equity-promoting participatory processes to address

the disproportionate impact of the coronavirus outbreak on communities that are already experiencing marginalization. The task force meetings also include collective policy updates and often a topical presentation from guest speakers on issues of interest to members.

VaxWell NH Coalition

VaxWell Coalition is an NHPHA statewide immunization coalition whose mission is to reduce vaccine-preventable disease by increasing immunization rates statewide. The Coalition continues to grow and currently has over 100 members, including, but not limited to, healthcare providers, public health professionals, schools, researchers, community organizations, and pharmaceutical companies, to name a few.

In 2022, the Coalition focused on implementing strategies to increase its membership and provide consistent and tailored services. Here are some of our accomplishments.

 Launched a new user-friendly website, including a list of resources designed for healthcare providers and the NH community.

- Planned and launched a digital campaign titled, Vaccination Starts with You in collaboration with the New Hampshire Division of Public Health Services. The Campaign announcement reached over five thousand healthcare providers and public health professionals in New Hampshire, Vermont, and Maine. The Coalition distributed over 2000 flyers and stickers directly to healthcare providers and to schools through the NH Immunization Program and Public Health Networks.
- Planned a session on Pediatric and Adolescent Vaccines on October 21, 2022.
 The session speaker was Wendy L.
 Wright, Owner and Family Nurse Practitioner at Wright & Associates
 Family Healthcare.
- Collaborated with Southern New Hampshire AHEC to have all future events approved for CME and CNE continuing education credits.
- Published VaxWell NH Coalition quarterly e-newsletter.
- Launched its first membership recruitment campaign.
- Recruited three MPH graduate students to write quarterly vaccine educational articles.
- Planned and organized its first Quarterly Coalition Meeting with its members on October 28, 2022. The meeting featured a vaccination update presentation by NH DHHS Acting Bureau Chief Dr. Ryan

Tannian; and a policy update by Andrew Hosmer, Senior Policy Advisor at PretiStrategies.

VaxWell strives to approach this work through an equity lens, supporting and amplifying the voices of partners who serve NH's most vulnerable populations, from rural, underserved communities in the North Country to communities of refugees and immigrants concentrated in our cities. While folks across the State face common barriers to vaccination, such as limited public transportation, complicated bureaucracy, unsupportive workplace policies, and widespread health misinformation, varied experiences of race, ethnicity, gender, and poverty also intersect to shape education and access to immunizations. Our goal is to convene as many diverse voices as possible, organize vaccine campaigns to build awareness and support future growth.

Enriching the Public Health Workforce

Public health workforce development is a strategic imperative for the NHPHA. The organization has successfully implemented various activities, including the Team Up Take Action (TUTA) Conference, a mentoring program, professional development training opportunities, student poster presentations, and student internships. Below are highlights of progress from 2022.

TUTA Conference

The seventh annual conference theme was Covid Pandemic and the Public Health Action: Rebuilding Through Alliances to Promote Health Equity. The TUTA conference was held virtually on December 9, 2022, in partnership with the Vermont Public Health Association, Maine Public Health Association, and Dartmouth Health. Eighty-five people registered and attended the virtual meeting. The meeting featured two keynote presentations and eight breakout sessions. The breakout sessions engaged attendees in lively questions and answers, discussion, and idea sharing.

Mentoring Program

The sixth cohort of the Mentoring Program held its kick-off meeting on October 13, 2021,

from 3:00 - 5:00 pm. The event featured a session on Social Media, Do's and Dont's presented by Rich Grant, Career Advisor at Southern New Hampshire University (SNHU). The event ended with an opportunity for mentees to network with the program mentors. Mentors and mentees met regularly via Zoom, where mentors have helped mentees with job applications, mock interviews, and networking opportunities. The Mentoring Program participants met on February 9, 2022, from 3:00 – 4:00 pm for a check-in Zoom meeting featuring a presentation by Dr. Gail Tudor, Public Health Program Director at SNHU, on Salary Negotiations, and a presentation by Leanne Skehan, Clinical Faculty, Health Professions at SNHU on Preparing Your Cover Letters and Resumes. In May 2022, the mentors and mentees came together for their final meeting and celebrated graduation and new jobs. Fifteen mentors and mentees attended the virtual event. Mentees provided feedback on the program and topics they would like to see added in the future.

Resource Management in Health Organizations Webinar

The webinar was held on Wednesday,

February 2, 2022, from 12:00 pm - 1:30 pm and was sponsored by the New England Public Health Training Center. This webinar examined the various aspects of resource management in health care, health organizations, and nonprofits. Resource management is the evidence-based process by which healthcare organizations effectively distribute human, capital, supply, and data resources to ensure operational and financial stability for the organization and quality care for individuals. The event was attended by twenty public health professionals.

Data for Decision-Making Webinar

The webinar was held on Tuesday, June 21, 2022, from 11:00 am – 12:30 pm and presented by Amy Costello, Director, Center for Health Analytics, Institute for Health Policy and Practice at UNH; Al Lemay, Business Systems Analyst, New Hampshire Division of Public Health Services; William Moir, Chief, Health Statistics and Data Management Section, New Hampshire Division of Public Health Services; and Jo Porter, Director, Institute for Health Policy and Practice at UNH. The event was well received and attended by twenty public health professionals. In this session, the presenters discussed common data used in public health. The event was sponsored by the New England Public Health Training Center.

Change Management in a Challenging Healthcare Environment Webinar

The Webinar was held on Thursday, July 21,

2022, from 12:00 - 1:30 pm and presented by Louise Keogh Weed, Instructor, Health Policy & Management, Harvard T.H. Chan School of Public Health. The event was attended by 13 public health professionals. In this session, the speaker provided an overview of change management theories. change management applications, how to create a sense of urgency as a pre-condition for change, how public health professionals should think about when leading change, and the current level of fatigue observed in the healthcare system within the context of change management in the current environment. The event was sponsored by the New England Public Health Training Center.

Student Poster Sessions

NHPHA had four undergraduate and seven graduate poster submissions at its Annual Meeting in April 2022. The students represented New Hampshire University and Plymouth State University.

NH Oral Health Coalition

The NHOHC, established in 2002, celebrated 20 years of oral health advocacy, and what a year it was! Through a strong bipartisan effort, and after two decades, our legislature established a Medicaid Adult Dental Benefit that supports the dental and overall health of over 88,000 adults by treating the dental disease early, in the right place, and at the right time. This program elevates NH out of the states providing emergency-only benefits and into the states with comprehensive, robust programs.

On July 1, 2022, Governor Christopher Sununu signed House and Senate bills into law and joined legislators, policy-makers, advocates, health and social service programs, families, and consumers alike in celebrating passage.

This program will improve the health of Medicaid beneficiaries while decreasing emergency room, inpatient, and chronic care costs. A great example of NH ingenuity is developing a plan for responsible management of our scarce resources. Following the signing, a public-private partnership including NH DHHS, Northeast Delta Dental, and the DentaQuest organization acted quickly to petition federal approval, establish benefit design, and create an infrastructure to ensure that the delivery of direct care could meet the launch date of April 1, 2023.

The Coalition, always poised to communicate, coordinate, and convene, reached out through our staff, steering committee, and many members to the planners, providers, implementors, consumers, advocates, and communities to help facilitate and support the success of the program. The Coalition scheduled ZOOMs, reviewed documents, wrote to providers, and supported advocacy efforts to ensure the broadest and strongest understanding of the development of the program. NHOHC supported special efforts put forward by the UNH Institute on Disability NH Leadership Oral Health Work Team and ABLE NH as they prepared materials specific to outreach for those living with disabilities. We are so proud of their work and collaboration. In NH, together we can, with whatever it takes. As a small nonprofit, it is seldom that we celebrate a milestone with an event that will improve the lives of thousands. We are so grateful to be part of this work.
